## 3. Scope of Work

- Furnish and mobilize all labor, and necessary equipment, to install bollards and planters
   (furnished by The Magnificent Mile® Association) at designated locations on Michigan
   Avenue. Placement at designated locations is outlined in the dimensional plan
   (Attachment A). Site Design Group will mark the locations assist in directing labor to
   ensure accuracy and compliance with City of Chicago standards. The bollards will be
   plate mounted to the cement.
- The bollards and planters will be shipped to your yard and then delivered and installed along Michigan Avenue. Labor, and all necessary equipment, is required for unloading, unpacking, and moving material to select locations.
- Labor is required for handling, removal and disposal of all packing materials.
