Glenn reported on the incidents from the previous period: Broken windows along the Mag Mile on July 9 (7 total, including bus shelters). There has been an increase in the number of people with mental health issues. Glenn reached out to Cook County (Marcus Vincent) to provide a mental health assessment and provide services. We had a carjacking attempt on

July 13 at Michigan + Ontario. Police were there and were able to apprehend the perpetrator. 38 premise checks, 4 community interactions, 6 field engagements. On July 7, United Security found doors open at Hugo Boss and Ralph Lauren. Numbers from CPD - July 8 - 16: 6 thefts, 1 battery.

Migrants: Glenn connected with BACP re: illegal food sales. A BACP task force came out and ticketed people.

Glenn has attended DNC Safety and Security meetings. The footprint for DNC will be released in the next couple of weeks. There should be no negative impacts for businesses on Michigan Avenue. There is an opportunity to help stuff delegate bags (10,000 total). August 15 there will be a welcome party for 115 people. There is a media party on August 17.

Glenn provided a list of events happening in the area. The Ambassadors will be working on the days of the events.

Jen had two comments: Downtown Day was a big success. Over 1,800 young people attended. She wondered about a palestinian protest - was it permitted? Glenn said yes. Jen is participating on a call re: security about DNC, she will forward the call info to the commissioners. July 25 from 3-4 pm.

Katrina presented the June financials and highlighted. Jen mentioned Olympik inquired about a deposit. Katrina shared the approved programming amounts approved last time with the commission.
